**Academic:** To gain entry you will need to have completed a bachelors degree from a recognised Indonesian university with the equivalent GPA of at least 3.0/4. No work experience required.

**English language:** International students must achieve an academic IELTS overall score of 6.5, all bands 6.0 or better or the TOEFL equivalent.

**Bahasa Inggris:** Mahasiswa internasional wajib mendapat nilai keseluruhan IELTS akademik 6,5, nilai 6,0 untuk semua mata ujian atau lebih tinggi atau nilai TOEFL yang setara itu.
