

Entry requirements

Academic: A bachelors degree from a recognised Malaysian university in either business or a relevant non-business discipline, with an average GPA of 3.0 (on a 0-4 point scale). The exact admissions requirement will depend on the ranking of the institution and discipline studied. No work experience required.

English language: International students must achieve an academic IELTS overall score of 6.5, all bands 6.0 or better or the TOEFL equivalent.



Syarat-syarat kemasukan

Akademik: Ijazah sarjana muda daripada universiti dari Malaysia yang diiktiraf dalam disiplin perniagaan atau bukan perniagaan yang berkaitan dengan capaian Purata Nilai Gred (GPA) 3.0 (berdasarkan skala nilai 0 – 4). Syarat-syarat penerimaan yang tepat bergantung kepada kedudukan institusi dan disiplin yang dipelajari. Tiada pengalaman kerja diperlukan.

Bahasa Inggeris: Pelajar antarabangsa perlu memperoleh skor keseluruhan IELTS akademik sebanyak 6.5, skor sebanyak 6.0 atau lebih baik dalam semua komponen atau yang setara dengan TOEFL.
